

Pursuant to Fed. R. App. P. 28(i) and Washington RAP 10.1(g), Respondent Robert Wilbur adopts in full the Brief of Respondent Admiral's Cove Beach Club. Specifically, Respondent Robert Wilbur adopts the following portions of the Brief of Respondent Admiral's Cove Beach Club: Introduction; Restatement of Issues; Statement of the Case; Argument; and Conclusion. For the reasons stated therein, Robert Wilbur asserts that the trial court correctly ruled on the Plaintiffs' Motion Summary Judgment and correctly ruled when it entered the Declaratory Judgment determining that the Admiral's Cove Beach Club community swimming pool was a recreational facility that could only be decommissioned after an amendment to the applicable bylaws and articles of incorporation; and that all parties were properly joined. The arguments submitted by Appellant are not supported by Washington law.

The Court of Appeals should sustain the trial court's decision to grant the Plaintiffs' Motion for Summary Judgment and affirm the related Declaratory Judgment entered in connection with that decision.
