Thinking ahead to generating secure ballots with tamper proof paper, and getting punch-cards and season family swim cards.

Here are my thoughts. We could also use a business card sized card for a season family pass, perhaps add family name and cove address in magic marker on the back at time of sale?

Your ideas? Shall we get purchases rolling?

We do need to agree on swim prices. We've kicked around \$50 family swim pass, \$20 - 5 swim punch card, \$5 single swim.

Business card size punch card – we would need to decide on the cost. I used \$20 for 5 swims on this. (The dotted line is not visible on the printed product). Cost: 250 for \$11.99, 500 for \$14.99 plus shipping and handling, availability about 2 weeks.
